I am to state that the General Body of this council at its meeting held on 26-27/03/2015 considered the Council assessor report (17.05.2014) on the standard of examination and other teaching facilities available at P.E.S. Institute of Medical Sciences & Research, Kuppam for purpose of Recognition of MD(DVL) qualification against increased intake 01 to 03 seats granted by Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh.

The Council approved the following recommendations of the Postgraduate Committee, which I am directed to convey herewith for your information and necessary action:-

"The Postgraduate Committee considered the Council assessor's report (17.05.2014) and decided to recommend that MD(DVL) qualification against increased intake 01 to 03 seats granted by Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh in respect of students being trained at P.E.S. Institute of Medical Sciences & Research, Kuppam be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of notification upon which the institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the postgraduate course.

Attention of the college authorities towards the observations made in the report requesting for a rectification of the report and a compliance report be sent."
