"The Postgraduate Medical Education Committee considered the Council Assessor's Report (May, 2014 for 4 to 6 seats and May, 2015 for 6 to 9 seats) and decided to recommend to the Central Government that MD(General Medicine) qualification against increased intake from 04 to 09 seats granted by Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh in respect of students being trained at P.E.S. Institute of Medical Sciences & Research, Kuppam be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition.
