#### 1. Regulations:

The following are the Regulations for admission into **Management Quota seats** in Post Graduate Medical & Dental Degree/Diploma Courses in all the Private Medical & Dental Colleges affiliated to Dr.YSR UHS.

#### 2. Number of seats under Management quota:

- The number of seats available for the academic year 2023-24 in Post Graduate Medical and Dental Degree/Diploma Courses in Private Un-aided Non-Minority and Minority Medical and Dental colleges will be in accordance with the orders of the NMC/DCI/GOI/Govt. of AP.
- The Seat Matrix for Management Quota seats will be displayed on the University Website (https://drysr.uhsap.in) before notification for web options
- Seat Matrix shall be prepared as per the following G.Os;
  - 1. G.O.Ms.No.70, dt.03-05-2017 as amended in G.O.Ms.No.57, dt.28-04-2023 of the Govt. of Andhra Pradesh (for Non-Minority Medical Colleges only)
  - i. Management Quota- Subcategory 1. -- 25% of the sanctioned intake of seats, course wise, in each of member institutions shall be filled by the candidates based on the NEET PG-2023 ranking.

#### As per G.O.Ms.No.102, HM&FW (C1) Dept., dated 15-07-2023,

- > 15% of Subcategory-1 seats only are open to the candidates from all over the Country.
- ➤ For the Remaining 85% of Subcategory-1 seats only Local Candidates of Andhra Pradesh i.e., AU/SVU are only eligible.
  - ii. Management Quota- Subcategory 2:-- 15% seats out of total intake capacity, course wise, in each member institution shall be filled by foreign students/NRI/NRI sponsored candidates on the basis of inter se merit among the applicants qualified in NEET PG-2023.
- iii. Management Quota- Subcategory 3:-- 10% seats out of total intake capacity, course wise, in each member institution shall be Institutional preference/In-service management quota seats filled on the basis of inter se merit among the applicants qualified in NEET PG-2023.

- iv. In case of fraction of 0.5 between Management Quota Subcategory-1 (S1) and Management Quota Subcategory-2 (S2), the fraction is to be rounded up to the figure and shall be rotated between Subcategory-1 and Subcategory-2 seats in the alternate years starting from the academic year 2023-24 i.e., for the academic year 2023-24, if the seat is due to fraction of 0.5 shall be meant for Management Quota Subcategory-1 and in the next academic year 2024-25 the same seat due to fraction of 0.5 shall be meant for Management Quota Subcategory-2 by rotation and so on as per G.O.Ms.No.57, HM&FW (C1) Dept., dt.28-04-2023 of the Govt. of Andhra Pradesh.
- 2. G.O.Ms.No.74, HM&FW (C1) Dept., dt.06-06-2023 of the Govt. of Andhra Pradesh rules related to Andhra Pradesh Private Medical/Dental Un-aided Minority Professional Institutions (Regulations of admissions into Post Graduate Medical and Dental Professional Courses) Rules, 2023.

#### 3. Eligibility:

- The candidates who fulfil the following criteria are eligible for admission into Post Graduate Medical and Dental Degree/Diploma courses and they have to fulfil the Regulations as per NMC/DCI.
- The candidates should secure the following cut-off scores in NEET PG-2023/ NEET MDS -2023 conducted by National Board of Examinations, New Delhi as per section (10) of Indian Medical Council Act, 1956.

#### Eligibility for Management Quota seats in Non-Minority Medical Colleges:

Sub Category-1 (S1):-

- ➤ 15% of Subcategory-1 seats only are open to the candidates from all over the Country.
- ➤ For the Remaining 85% of Subcategory-1 seats only Local Candidates of Andhra Pradesh i.e., AU/SVU are only eligible.

#### 4. Local Area:

1. The entire state of Andhra Pradesh shall be treated as two local areas for the purpose of admissions into Post Graduate Courses in Medical and Dental Colleges" i.e., Andhra University and Sri Venkateswara University (including SVIMS) areas for filling up the 85% of Sub category-1 (S-1) seats in private un-aided Non-minority Medical and Dental Colleges in the State of Andhra Pradesh.

- 1. MBBS from Govt. Siddhartha Medical College, Vijayawada
- 2. BDS from Govt. Dental College, Vijayawada/Govt. Dental College, Hyderabad

  <u>The Local area of the candidate shall be decided by considering the maximum study</u>

  <u>period of 4 years out of 7 years of study from 6<sup>th</sup> class to Intermediate/10+2 in the</u>

  State of Andhra Pradesh.
- Foreign Students/NRI/NRI sponsored candidates are eligible for Category C (NRI Quota
   Sub Category-S2)
- Candidates sponsored by the Managements of Private Medical/Dental Colleges having Post Graduate Courses in Andhra Pradesh State are eligible for Category C (Institutional Quota Sub Category-S3) in the college which sponsored his/her candidature. The requirements for the Institutional Quota are:
- 1. The candidates who have completed MBBS/BDS in that particular Institution.

2. Employee of that particular Institution and the employee should have a minimum of 6 months experience in that particular Institution and presently working as on the date of application in the same Institution.

#### Eligibility for Management Quota seats in Minority Medical Colleges:

# G.O.Ms.No.74, HM&FW (C1) Department, dated 06-06-2023 in case of Minority Medical Colleges

- > 50% of Seats in each speciality in each college are Management Quota Seats.
- > The Seats are categorised into
  - 1. Management Quota Category B (S1)– 25%,
  - 2. Category C (NRI- S2) 15%
  - 3. Category -C (Institutional Preference S3) 10%.
- a. Management Quota-Subcategory- 1(S1): 25% of the sanctioned intake of seats, course wise, in each institution shall be filled by the candidates in General Merit based on the NEET PG-2023 ranking.
- b. Management Quota-Subcategory-2(S2): 15% seats out of total intake capacity, course wise, in each institution shall be filled by foreign students/ NRI/NRI sponsored candidates on the basis of inter-se-merit among the applicants qualified in NEET PG-2023.
- c. management Quota-Subcategory-3(S3): 10% seats out of total intake capacity, course wise, in each institution shall be Institutional preference/In- service management quota seats filled on the basis of inter-se-merit among the applicants qualified in NEET PG-2023.
- Candidates should have MBBS/BDS Degree recognized by the NMC/DCI.
- Candidates should have completed Internship by

For PG(Medical) course : 11-08-2023 For MDS Courses : 30-06-2023

Must have registered with Medical Council/Dental Council.

Note: If a candidate is found to have submitted false information or concealed any relevant information such candidate is liable to be disqualified for admission and in case already admitted, the admission will be cancelled. Further disciplinary action against him/her will be taken by the University/respective institution. Legal issues if any shall be under the High Court of Judicature for the State of Andhra Pradesh.

- If the candidate is having a Medical qualification equivalent to MBBS/BDS (Primary Medical/Dental qualification) from outside India, the Degree should have been recognized by NMC/DCI for enrolment as Medical/Dental Practitioner in the India.
- Candidate must have Permanent Registration with Medical Council of India/Dental Council of India or any State Medical Council/Dental Council.

Candidates must pay equivalency verification fee as specified in the regulations along
with the registration fee. The fee once paid will not be refunded or adjusted to a future
date. Therefore, candidates are advised to check eligibility conditions thoroughly before
applying for determining merit.

**Senior Residency:** All the candidates admitted into Management quota seats in unaided private Medical/Dental colleges, on completion of their Postgraduate course shall work for one year as 'Senior Resident' in the institution where they pursued postgraduate course. "

2. The Registration fee, Processing fee & Equivalency fee including 18% GST:

For candidates studied outside the AP/TS State and Abroad

- **a.** The candidates who acquired their MBBS Degree outside the AP/TS State shall pay **Rs.10,620/-** (i.e., Rs.3,500/- + 2500/- + 3000/- and 18% GST)
- **b.** The candidates who acquired their MBBS/BDS in Abroad/Foreign Country shall pay **Rs.15,340/-** (i.e., Rs.3,500/- + 2500/- +7000/- and 18% GST)

#### 8. Merit Lists:

- The Merit Position of the candidates those who have applied through online in response to the notification issued by Dr.YSR University of Health Sciences for Management Quota Seats shall be determined by **NEET PG-2023/NEET-MDS-2023** Ranks and as per their eligibility criteria, applicable regulations, guidelines.
- The University will release final merit position of eligible candidates for exercising web options after verification of uploaded scanned certificates by Dr.YSR UHS, Vijayawada.

#### 9. Fee Structure:

#### University Fee:

All the selected candidates shall pay the Non – Refundable University Fee of **Rs.49,600/**-for Medical & Dental courses.

#### **❖ PG – Medical& Dental Courses:**

Tuition fee for PG Medical and Dental Courses in Private un-aided Minority and Non-Minority Medical and Dental courses will be as fixed by the Government of Andhra Pradesh.

#### 10. ADMISSION RULES:

The last date of joining of selected candidates will be communicated to them in the letter of selection.

- All the candidates joining the Post Graduate degree/diploma courses should execute bond on a stamped paper of Rs. 100/- value as prescribed in Annexure-IV to the effect that he/she will complete the prescribed period of training or in default to pay Rs.3,00,000/- + 18% GST to the University and shall refund the amount received as stipend upto that date to the Government as notified by the University from time to time.
- As per G.O.Ms.No.67, HM&FW (C1) Department dated 21-04-2017 candidates have to pay the discontinuation penalty of Rs. 3,00,000/- + 18% GST and they will be debarred for three years for admission into Post Graduate Medical Degree/Diploma courses at the colleges in the State of Andhra Pradesh for admission into PG Medical courses subject to receipt of orders from the Government if any and as notified by the University from time to time.
- **11. ATTENDANCE:** Candidates selected for the various courses should be the whole-time students. The candidate is required to put in a minimum of 80% attendance during each calendar year for being eligible to appear for the University examination.

In a year all 365 days will be considered as working days and students should get 80% attendance each year separately to get eligibility for appearing University exams. The remaining days of absence (including maternity leave) will be considered for extension of study period.

- **12.LEAVE:** Students will be permitted to avail 30 days leave per year. No Post Graduate is allowed to go on leave more than 8(Eight) days at a stretch. Incase the absence of the candidate availing Medical Leave/Maternity Leave/Any other Leave or unauthorized absence is beyond 30 days in a year, the study period of the candidate will be extended to the extent of such period. No other leave is permitted.
- **13.MATERNITY LEAVE:** Women students can avail maternity leave upto 120 days only once in their PG course of study and the study period will be extended to the extent of Maternity leave availed. The candidate shall not be eligible to appear in the University examinations till the completion of study period as per NMC/DCI Regulations (Duration of course).

- 14. BREAK OF STUDY AND RE-ADMISSION: If a student is absent continuously for a period of 91 days or more and seeks permission to attend the course, his / her application in prescribed format vide annexure V & VI by paying requisite fee in favour of Registrar, Dr YSR University of Health Sciences payable at Vijayawada shall be forwarded to the Registrar, Dr.YSR University of Health Sciences with the recommendation of the Principal. The candidates are advised to refer the regulations before submitting the application and paying the fee. If they fulfill the conditions, they may submit applications through the Principal of the College by paying the fee.
  - **15.PRIVATE PRACTICE:** No Post Graduate is allowed to do any private practice or consultation and should not accept any part time employment in any State or Central or Quasi Government or Private organizations during the period of Post Graduation study. The Principal has to take appropriate action after giving opportunity for explanation, if any student violates this rule.
  - **16. COLLEGE REGULATIONS:** Candidates are required to follow the rules and regulations of the college and should also abide by the regulations of the University. Under any circumstances they should not have any correspondence with the higher authorities directly without routing through proper channel.

#### 17. CLOSURE OF ADMISSIONS:

- The admissions shall be closed as on the date as notified by the NMC/DCI, New Delhi.
- Any vacancy as on the date of closure of admissions shall not be filled. They will
  not be carried forward to the next year as per the directions of Supreme Court of
  India.

#### 18.DURATION OF COURSE:

The duration of P.G. Diploma courses is 2 years and P.G. Degree courses is 3 years from the date of commencement of the course. In case of students having a recognized two year Post Graduate Diploma course in a subject selected for PG Degree in the same subject, then the period of training including the period of examination, shall be two years. If the break of study is more than three months the candidate has to apply (vide Annexures-V & VI) to the University through the Principal/Dean of the college. The University can give permission to the candidate to complete the course as per Rules based on evidences produced by the candidate for the break of study.

#### 19.DISSERTATION:

The Post Graduates who are admitted must register the topic of their dissertation with the University within six months of commencement of the course and approval of the University should be obtained.

The dissertation should be submitted within 2½ years of commencement of the Course. In the case of the candidates who are granted exemption of one year of study period of degree course, the dissertation should be submitted within 1½ years of commencement of the course. If the above schedule is not followed the period of Post Graduation will be extended by six months.

- A Postgraduate student shall present one poster presentation, to read one paper at a National/State conference and to present one research paper which should be published/accepted for publication/sent for publication during the period of his/her Postgraduate studies so as to make him/her eligible to appear at the Postgraduate Degree University examination.
- ➤ The UGC Notification, dt.23-07-2018 published in the Gazette of India regarding "Promotion of Academic Integrity and Prevention of Plagiarism in Higher Educational Institutions, Regulations 2018" are in force from the academic year 2021-22.

#### 20. POWERS OF PRINCIPALS:

Notwithstanding anything contained in these regulations, the Principals of the respective Colleges may at any time before completion of the Post Graduate course either on their own or on the application of any person after due and proper enquiry and after giving the person two weeks time from the date of the receipt of the show cause notice to submit written explanation and on personal hearing, order, cancellation of admission to the 1<sup>st</sup> year Post Graduate Degree/Diploma course if in the documents attached thereto or in the Statements made either before the authority in charge of admission or the Principals or in any other manner. Against any such order of the Principal an appeal shall lie with the Registrar, Dr. YSR University of Health Sciences, A.P. Vijayawada.

#### 21.POWERS OF Dr.YSR UNIVERSITY OF HEALTH SCIENCES:

Dr.YSR University of Health Sciences, Vijayawada may either suomoto or on an application made to them, call for and examine the records relating to any selection or admission or cancellation thereof in respect of the admission made by the concerned authority, for the purpose of satisfying themselves as to the correctness of legality or propriety of such selection or cancellation and pass such order in relation there to as they deem fit including cancellation of the selection already published or admission already made, provided that the University may, before cancelling such selection or admission, give an opportunity to the authority and to the person affected to show cause against such cancellation. Dr.YSR UHS has every right to cancel the admission of any candidate without any notice, if the certificates produced by the candidate are found to be fake/false/forged.

Note: If a candidate is found to have submitted false information such candidate is liable to be disqualified for admission and in case already admitted, the admission will be cancelled. Further disciplinary action against him/her will be initiated by the University as per rules.

#### 22. RAGGING:-

- The candidates who join PG Medical/Dental Courses should not indulge in any kind of agitation / strike / ragging activity inside / outside the college campus during the course of study. The candidates if found to take part in any such activities mentioned above will be expelled from the course / college at any part of the course of study and legal proceedings / criminal action will be initiated against them.
